2016 Generations United Photography Contest Contest Guidelines

Generations United is a national membership organization focused solely on improving the lives of children, youth, and older people through intergenerational strategies, programs, and public policies. To help unleash the potential of Generations from A to Z, we are holding an intergenerational photography contest.

Purpose:

We are looking for photographs by photographers of any age that depict youth and older community members engaging in activities that smash the silos that separate the generations and release the energy that comes from uniting them.

Prizes:


- **Grand Prize: \$100**
- **Second Prize: \$75**
- **Third Prize: \$50**
- **Audience Favorite: \$50** - determined by votes from *Generations This Week* subscribers (Subscribe to [Generations This Week](http://www.generationsunited.org/gtw)).

Use of Photographs:

Contest entries may be used in Generations United's websites, publications or other products. We will give credit to all photographers whenever their photos are used.

How to Enter:

We encourage all entrants to submit their photos online using the form available at <https://generationsunited.wufoo.com/forms/p156mefw0schjhx/>. Please complete the form and upload your digital image.





Deadlines:

- All entries must be received by March 15, 2017.
- Winners will be notified no later than May 1, 2017.

Photographic Standards:


- Photographs can be either color or black-and-white.
- Only digital photographs will be considered.
- Digital photos must have a minimum resolution of 300dpi and preferably be at least 1875 pixels by 2850 pixels in size.
- Minor digital enhancement such as cropping, red-eye removal, filters and other minor corrections are permitted. *However, any images that our judges determine to be significantly altered will be disqualified.*
- Do not place borders or frames around your image(s) or place a watermark, signature, date, or copyright notices on any image.


Judging:

Judges for the 2016 photo contest will include professional photographers, Generations United board members, and individuals with experience with the 2016 contest theme and the work of Generations United. The judges will evaluate images based on originality, composition, overall impact, and representation of Generations United's 2016 photo contest theme. The most effective photographs illustrating the theme, "Generations Unleashed Equal Value Unleashed," are most likely to focus on a specific activity or participants in close-up. Eligibility:

- Contest is open to photographers of ALL ages.
- Only entries received through the online form or via Instagram by 11:59 pm ET on March 15, 2017 will be considered.
- Each contestant may enter up to four photographs total.

The contestant agrees to indemnify and defend Generations United, Inc., its directors, officers, trustees, employees, agents, attorneys, representatives, successors, and assigns against any claims or complaints that may arise out of his or her entry.
