Nursing Home Abuse/Neglect

Nursing home abuse and neglect are viewed as some of the most despicable acts in our society. Anytime an individual is harmed, neglected, or taken advantage of, it is extremely unfortunate. This is especially true when the victim is powerless to prevent their ongoing victimization.

Although nursing home abuse and neglect are similar and sometimes occur simultaneously, understanding the difference in them could help you better recognize when your loved one is being victimized.

Abuse is defined as mistreating a person physically, emotionally, or psychologically, while neglect involves the failure to properly care for someone physically or psychologically. Both abuse and neglect carry the potential for devastating effects on their victims.

Types of Nursing Home Abuse

Physical Abuse

Physical abuse is typically the easiest to recognize, as visible marks are often left. Physical abuse can occur when a victim is punch, slapped, scratched, pushed, inappropriately restrained, or is otherwise harmed through physical force. Signs of physical abuse can include scars, cuts, scrapes, broken bones, and bruises. All of these signs can be used to help prove that you or a loved one has been the victim of physical abuse. When this kind of abuse occurs, it is important to document any injuries and seek medical attention when necessary.

Emotional Abuse

Emotional abuse involves the intentional causing of emotional distress to the nursing home resident. When an individual is verbally assaulted, humiliated, terrorized, demeaned, or otherwise emotionally mistreated, he or she could have a valid personal injury claim against his or her caregivers. While this type of mistreatment leaves no physical marks, it is important not to underestimate the damage that a victim suffers.

Sexual Abuse

Sexual abuse takes place where non-consensual sexual activity occurs against a nursing home patient. This type of abuse can happen when the victim is forced, deceived, enticed, or otherwise manipulated to participate in sexual activity against their will, or when they were not completely aware of what was taking place.

Financial Abuse

When caregivers at a nursing home take advantage of patients by stealing money or property from them, the patient has been the victim of financial abuse. This type of abuse most often occurs when a victim is tricked or forced into giving up information such as bank account numbers, debit card numbers or PINs, and other private financial information. Financial abuse can also occur when a victim is pressured into changing beneficiaries in a will or on an insurance policy, or modifying their deed.

Types of Nursing Home Neglect

Anytime a nursing home patient does not receive adequate emotional, physical, or medical attention, he or she is a victim of nursing home neglect. Examples of nursing home neglect include:

- Social: Isolating or ignoring the patient, which can lead to depression, deterioration of mental faculties, and even medical concerns.
- Medical: Failing to provide medication, change bandages, treat injuries, etc.
- Basic: Forcing the patient to live in substandard conditions or eat substandard food, leading to a lower quality of life.
- Hygiene: Failing to ensure that the patient has bathed, brushed teeth, and performed other tasks essential to good hygiene. Failure to provide consistent hygienic care can lead to serious medical conditions, as well as a substandard quality of life.

Nursing home neglect could lead to serious mental, medical, health, or hygiene issues. Even a seemingly minor incident of neglect can have a substantial impact on residents, or could be indicative of larger issues. Patients who are neglected could develop mental health disorders, bed sores, infections, and other conditions.

Taking Legal Action against a Nursing Home after Reports of Abuse or Neglect

When you believe that a loved one has been the victim of nursing home abuse or neglect, removing the patient from the nursing home is critical. It is important to prevent any further damage from being done to the patient. Once the patient has been removed from the dangerous environment, you can begin the process of taking legal action against the nursing home.

In many cases, the responsible party will attempt to offer the victim of nursing home abuse/neglect a quick settlement.
