#### **Rail Overview**

Washington is home to dozens of passenger, freight, and commuter rail lines, as well as rail suppliers. Washington ranks 7th for the number of railroads and 12th for the number of freight rail employees. It also ranks 12th in commuter ridership.



### Freight

**30** freight railroads, including Class Is like **BNSF** and the Union Pacific Railroad and short line railroads like the Palouse River & Coulee City Railroad and the **Puget Sound & Pacific** Railroad move more than **2.3** million carloads of intermodal, farm products, lumber and other types of freight over 3,032 miles with more than **4,300** employees.



### Amtrak

WA has **2** long distance Amtrak routes and **1** state supported route that serve the state, including:

- Coast Starlight
- Empire Builder
- Cascades

More than **1.3** million train riders are served at WA stations each year.

In FY17, Amtrak spent **\$18.4** million on goods and services in WA and employed more than 470 residents.



#### Commuter

**Commuter rail provides** more than 4.6 million passenger trips each year on Sound Transit's Sounder commuter rail, which has 2 lines and 12 running from Everett, Seattle and south to Lakewood.

The Sounder is operated by BNSF.

Suppliers

**Suppliers** The rail supply industry contributes more than **\$1.4** billion to WA's GDP and supports more than 11,500 jobs, including 3,039 direct jobs in WA through companies like Union Tank Car, Greenbrier, TTX Company, and Progress Rail.

## Did you know?

It would have taken approximately 7 million additional trucks to handle the **126** million tons of freight that originated in, terminated in, or moved through WA by rail in 2017.
